NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 180 of the Electricity Act, 2003 (Central Act 36 of 2003) read with regulation 29 of the Central Electricity Authority (Measures relating to Safety Electric Supply) Regulation, 2010, the Government of Karnataka hereby makes the following rules further to amend the Karnataka (Licensing of Electrical Contractors, Special wiring permit and grant of certificates and permits to Electrical Supervisors and Wiremen) Rules, 2012, namely:-

1. Title and Commencement. - These rules may be called the Karnataka (Licensing of Electrical Contractors, Special wiring permit and grant of Certificates and permits to Electrical Supervisors and Wiremen) (Amendment) Rules, 2021.

(2) They shall come into force on the date of their publication in the Official Gazette.

- 2. Amendment of rule 12.- In the Karnataka (Licensing of Electrical Contractors, Special wiring permit and grant of Certificates and permits to Electrical Supervisors and Wiremen) Rules, 2012 (hereinafter referred to as the said rules) in rule 12, in sub-rule (1), in clause (b), in the proviso for the words "ten years" the words "five years" shall be substituted.
- 3. **Amendment of rule 19.-** In rule 19 of the said rules, in sub-rule (3), for the words "Diploma in Electrical" the words "Diploma in Electrical or Mechanical or Electronic or Instrumentation" shall be substituted.
- 4. **Amendment of rule 24.-** In rule 24 of the said rules, in sub-rule (6) for clause (d) the following shall be substituted, namely. -

"(d) is holding a valid Wireman permit for Electrical Supervisor (Mines) Grade-2"

5. **Substitution of rule 36.-** For rule 36 of the said rules, the following shall be substituted, namely. -

"36. Change of License Nomenclature, change of License from Individual to Partnership firm/Company and vice versa, Authorized Signatory, Address, Partners/Directors and Instruments. - (1) Any Change of License, Nomenclature or change of License from Individual to Partnership firm/Company and vice versa or address or change of partners or directors or authorized signatory or change of instruments may be affected in the original records of license/permit holder subject to the all essential documents being furnished as specified in Annexure-6.

(2) An application under sub rule (1) shall be made to the Member Secretary, duly signed by the applicant and submitted at the office of the Chief Electrical Inspector to Government, Bengaluru accompanied by the original license/permit, required documents and Treasury challan for having remitted the requisite fee as specified in Annexure-5.

(3) Change in the firm name and change of license. -

- For change of firm name, if any Registered Company possessing valid license issued under these rules desires to change its nomenclature, in the event of change over or taken over or merger or de-merger, shall be considered subject to all necessary documents being required to be furnished under the provisions of the Companies Act, 2013 (Registrar of Companies).
- ii. For change of License from Individual to Partnership firm/Company and vice versa, the applicant shall fulfill the following conditions, namely:
- ii. The license holder of individual shall apply for change of his individual license to partnership/company afresh and shall satisfy all the conditions specified in rule 12;
- iii. The partner/member of Directors of company should financial partners only and all the members shall satisfy to the general conditions as mentioned in rule 12;
- iv. Change of his individual license to partnership/ company or vice versa, class of the license shall not be altered;
- v. Existing licensing holder shall be the applicant and authorized signatory; and
- vi. The applicant shall have more than 51% of share in proposed Partnership firm/Company.
 - 6. **Amendment to Annexure-5.-** In Annexure-5 of the said rules, under sub heading "E-OTHERS", after serial number 8, the following shall be inserted, namely.-
- 9 For change of Signatory or Partners/Directors of the firm/company/factory,
 (a) any License or
 (b) Special wiring permit Fees-
