GOVERNMENT OF KARNATAKA (ELECTRICAL INSPECTORATE)

I. FUNCTION AND DUTIES OF THE DEPARTMENT OF ELECTRICAL INSPECTORATE:

The Head Quarters of the Electrical Inspectorate is located at Ground Floor, Mysugur Bldgs, (Annex), J.C.Road, Bangalore 560 002. The department has six zonal offices at Bangalore South, Bangalore North, Mangalore, Tumkur, Dharwad and Bellary headed by the Deputy Chief Electrical Inspector's. There are 18 Electrical Inspectors working as Divisional Officers in the field, 33 Deputy Electrical Inspector's are working as sub-divisional officers. All these officers are assisted by 71 Asst.Electrical Inspectors.

The main objectives of this department is to ensure that all the electrical installations of the State are in general conformity with the provisions of I.E.Rules 1956 with a specific intention of minimising the danger caused by the electricity to human beings, animal life and to the property.

The scrutiny and approvals of drawings of Electrical installations of suppliers, licensees, IPPs, Generating Stations, (Hydel, Thermal, Wind and Diesel) Lines, MUSS, Consumers EHV, HV, DG sets, T.G.Sets, Multistoreyed Buildings, installations, the initial inspections and issue of commissioning approval of the above installations along with 'X'-ray & Neon Sign installations. To ensure safety and to implement safety provisions laid in act & rules this department conducts periodical inspection of the above said installations along with MV- installations.

The scrutiny and approval of drawings for electrical installations of all new and renovated cinema. The initial and periodical inspections of cinema installations along with the grant of electrical fitness certificate to them.

The processing of the applications and drawings for permission to erect lift and escalators, initial inspection of lifts and escalators along with the grant of licences to them. The scrutiny of applications for enlistment of lift manufacturers and maintenances and also investigation of lift accidents.

The initial inspections of video installations along with the grant of Electrical safety certificates to them.

The grant of licence to Electrical Contractors and special wiremen permits, Issue of Electrical and mining supervisor's permit and also wiremen permits along with their renewals, permission for oil filtering, calibration of Metering & protection equipments. The enquiry of disputes between the suppliers and Electrical Contractors & between Licensed Electrical Contractor and consumers. Conducting the Licensing and Advisory Examination board Meetings, Examinations of Electrical and Mining Supervisors and also wiremen.

To conduct examination for cinema operator & to issue permits for successful candidates.

The department oversees the collection of tax on consumption of electricity as laid in taxation act & rules from KPTCL, KPCL, Hukkeri Cooperative Society, all ESCOMS, all IPP's etc..

II. THE POWERS AND DUTIES OF OFFICERS AND EMPLOYEES OF HEAD OFFICE:

CHIEF ELECTRICAL INSPECTOR TO GOVT:

The chief Electrical Inspector to Govt, is the head of the department and is also Ex-Officio – Additional Secretary to Govt (Licensing) Department of Energy, Chairman Licensing Advisory and Examination Board, Chairman Cinema Operators Examination board, Member of Central Electricity Authority, Panel Member of ISS Committee on ISS for lifts and escalators, State Inspection Officer of Lifts and Advisor to Govt on Electricity matters. He is responsible for the activities of the department.

DEPUTY CHIEF ELECTRICAL INSPECTOR(HQS)

The Deputy Chief Electrical Inspector(Hqs) will assist the Chief Electrical Inspector to Govt in taking decisions in respect of Administration, Electricity Tax, Accounts, Technical matters, conducting Supervisor and Wiremen Examination and also Cinema Operator's Examinations, DCB and collection of arrears. He is also Member Secretary for Licensing Advisory and Examination Board. He will be responsible for decision making in the matters of total administration of department & other related issues.

ELECTRICAL INSPECTOR (ADMN, TAX & MANUAL)

He will assist Deputy Chief Electrical Inspector(Hqs) in the matter of Administration, Electricity Tax and manual matters. He will be assisted by Deputy Electrical Inspector (Manual), Accounts Officers and staff of the head office. He is also Member Secretary for cinema Operator's Examination Board. He is responsible for the administration of the department and in matters related to tax, manual and in according permission for enlistment and licences to run Lift and escalators and in matters related to Cinema Operator Competency Examination Board.

ELECTRICAL INSPECTOR(TECHNICAL)

He will assist the Chief Electrical Inspector to Govt., and Deputy Chief Electrical Inspector(Hqs) in all the Technical matters of the Head Office. He will be assisted by two Deputy Electrical Inspectors & two Asst. Electrical Inspectors. He is responsible in scrutinising and approval of electrical installation drawings, in finalization of Fatal electrical accident to Human beings and in any other matter assigned to him by Chief Electrical Inspector to Govt.

ELECTRICAL INSPECTOR(LICENSING, LABORATORY & APPEALS)

He will assist the Chief Electrical Inspector to Govt and Deputy Chief Electrical Inspector (Hqs) in the matters pertaining to Licensing Advisory and Examination Board (i.e. Issue of Electrical Contractors Licences, Special wiring permission, supervisors permits, wiremen permits and their renewals) conducting the Electrical and Industrial Supervisors Examination and also wiremen examinations. He has to look after the Laboratory and appeals works. He will be assisted by Deputy Electrical Inspector(Licensing Deputy Electrical Inspector (Appeals), and Asst.Electrical Inspector(Lab), First Division Assts and Second Division Assts. He is responsible in the matters related to issue of Licences, permits, in pertaining to Licensing Advisory & Examination Board, Appeals & also in Laboratory, permission for oil filtering and calibration of metering and protection equipments.

ACCOUNTS OFFICER:

Accounts Officer is assisting Chief Electrical Inspector to Govt, Deputy Chief Electrical Inspector (Hqs) and Electrical Inspector, (Admn, Tax, Manual) in all the matters of accounts and taxation. He is responsible for auditing of electricity tax pertaining to licensees and non-licensees under Karnataka Electricity (Taxation on consumption) Act1959 and also replies to AG audit paras.. He is assisted with Manager, superintendents, First Division Assts.and second Division Assts

DEPUTY ELECTRICAL INSPECTOR(MANUAL)

He will assist the Electrical Inspector (Admn, Tax, Manual). He is responsible for maintenance of the statistical informations and procession of all the matters with regarding issue of enlistment, grant of licences for lifts and escalators.

DEPUTY ELECTRICAL INSPECTOR'S- 1 & 2 (TECHNICAL) ANDASST.ELECTRICAL INSPECTOR, 1& 2 (TECHNICAL)

They will assist the Electrical Inspector (Tech) in all technical matters concerned their jurisdiction. They will be responsible for the scrutiny of drawings of Electrical installations of suppliers, licencees, IPP's, Generating Stations(Hydel, Thermal, wind and Diesel), lines, MUSS, consumers EHV, HV, DG set, TG set Multistoreyed buildings and also for finalisation of fatal electrical accidents to human beings.

MANAGER

He will assist Electrical Inspector (Admn, Tax, Manual) Accounts Officer in all the matters of accounts and taxation. He is assisted with superintendents, First Division Assts, and Second Division Asst's. He is responsible for compilation of all the statements, financial matters and also replies to AG audit paras.

SUPERINTENDENTS:(ADMN)

He will assist Electrical Inspector (Admn, Tax, Manual) in the work of Administration and Service matters, Budgets and its reallocations, Salaries, Court cases pertaining to administration matters and the issues pertaining to tax rebates to all Escoms, etc. and He is responsible for the above works. He is assisted with First Division Assts and Second Division Assts.

SUPERINTENDENT 1 & 2 (TAX):

They will assist Manager in all the matters of electricity tax. They are responsible for the maintenance of tax ledgers, reconciliation of tax revenue, pursuance of tax revenue. Superintendent -1 (Tax) is responsible for all the matters concerned to court cases and Superintendent-2 (Tax) is responsible for all the matters and paras of AG's audit. They are assisted with First division Asst's and Second Division Asst's.

FIRST DIVISION ASST. & SECOND DIVISION ASST.

He is responsible for compilation of statements and tappals, put up their note, monitoring of file clearance, maintain and preserving the files, Inward and outward of applications / papers received and to be dispatched from the office.

POWERS AND DUTIES OF THE OFFICERS AND EMPLOYEES WORKING IN THE FIELD OFFICES:

DEPUTY CHIEF ELECTRICAL INSPECTOR (ZONAL):

He is zonal officer & administrative control officer for his zone. He is responsible for submission of consolidated progress reports, DCB, expenditure statement, treasury challon reconciliation of his zone to head office, for finalization of Non-fatal electrical accidents human beings and fire accidents and in any other matter assigned to him by Chief Electrical Inspector to Govt.

ELECTRICAL INSPECTOR (DIVISIONAL):

He is the head of the Divisional office. He is responsible for submission of consolidated progress reports, DCB, expenditure statement, treasury challon reconciliation & RCB Extract of his division & for finalization of Fatal electrical accidents to animals. He is also responsible for the investigation of fire accidents and in any other matter assigned to him by his zonal Deputy Chief Electrical Inspector.

DEPUTY ELECTRICAL INSPECTOR (SUB DIVISIONAL):

He is the head of the sub-divisional office. He is responsible for his works as per delegation of powers, submission of consolidated progress reports (including his Asst. Electrical Inspector's), DCB, expenditure statements reconciliation

statements, RCB extract. He is also responsible for investigating the Fatal electrical accidents to human beings and to submit his investigation report to the higher officer in any other matter assigned to him by his Divisional Electrical Inspector.

He shall maintain all statistical information with regards to installations, accidents & other activities in his area.

ASSISTANT ELECTRICAL INSPECTOR:

He is working in accordance with delegation of powers. He is responsible for the submission of monthly progress reports, DCB, expenditure and reconciliation statements, investigation reports of the electrical accidents to Animals and Non Fatal electrical accidents to Human beings.

III. PROCEDURE FOLLOWED IN THE DECISION MAKING PROCESS INCLUDING CHANNELS OF SUPERVISION AND ACCOUNTABILITY:

Applications for grant of electrical drawing approval for the installations of suppliers, licencees, IPP's, generating stations lines MUSS consumers EHV, HV, DG set, TG set, Multistoreyed Buildings, Issue of Electrical Contractor's licencees, Supervisor and wiremen permits, special wiring permits, Issue of cinema operator's permits, received to this office (this department), is being verified / scrutinized for the required specific, then the necessary fees will be collected and scrutinised, if the processed applications are in order they will be cleared, otherwise informed to comply the requirements.

The above said procedure will also be followed by the jurisdictional field officers of this department.

The periodical inspection will also be carried out for all the above said Electrical installations along with MV installations, X-ray installations and Neon-sign installations by various inspecting officers, the necessary inspection fees levied as per the prescribed rates.

The Chief Electrical Inspector to Govt, will be the final decision making authority in any revisions and clarifications.
